Overview

Spectral graph theory is about how eigenvalues, eigenvectors, and other linear-algebraic quantities give us useful information about a graph, for example about how well-connected it is, how well we can cluster or color the nodes, and how quickly random walks converge to a limiting distribution. Spectral graph theory has turned out to be extremely useful in theoretical

computer science, with applications ranging from solving linear systems, converting randomized algorithms to deterministic algorithms, sampling via Markov Chain Monte Carlo, counting, web search, and maximum flow. In this course, we will study both the mathematics and the algorithmic applications of spectral graph theory, including some results from the past couple of years. Along the way, we will cover a number of concepts and tools that are quite broadly useful, such as mixing of Markov chains, expander graphs, algorithmic linear algebra, and the multiplicative weights method for optimization.

Learning Outcomes

By the end of the course, we hope that you will all be able to:

- Comfortably use linear-algebraic tools in designing algorithms and in studying graph-theoretic problems,
- Extract both the high-level ideas and low-level details when reading a text and identify interesting questions that are not answered,
- Explain and collaboratively work through an advanced theory subject with your peers,
- Understand the state of the art in algorithmic spectral graph theory as needed to engage in research in this area and/or apply it to other areas.
- Formulate and carry out an interesting, short-term independent project, and present the work in both written and oral form.

Prerequisites

CS 124 and linear algebra at the level of AM 22a or Math 21a. We strongly encourage doing Problem Set 0 and turning it in for feedback to gauge your preparation for the course.

Format and Expectations

The main class meetings (TuTh 1:30-2:45pm Eastern time via Zoom) In addition, Chi-Ning will hold a section every other week, and both Salil and Chi-Ning will hold online office hours at multiple times of the day to accommodate a variety of time zones. Furthermore, we will hold several online social gatherings (e.g. using [gather](#)) to create a community within the class and facilitate finding partners for problem sets and projects.

The main components of the course are as follows:

- **Main class meetings (TuTh 1:30-2:45pm Eastern):** These will be interactive lectures, with the exposition and discussion guided by student questions and comments, interspersed with occasional problem-solving and brainstorming in breakout groups. Students are expected to attend these meetings, and keep their cameras on during class.
- **Section (every other week, time TBD):** A section will be held every other week, at a time TBD to accommodate as many students as possible. The sections will include guided work on practice problems, review of difficult concepts, and supplementary material. Attendance is not required.
- **Office hours (every week, at multiple times):** Salil and Chi-Ning will hold office hours

at multiple times of the day to accommodate students in a variety of time zones.

- **Reading and commenting:** to allow our class meetings to be more interactive, short advance reading will be assigned for most class meetings, and you will be expected to comment on those readings using the social e-reader [Perusall](#). Salil will often record a short video to help guide you through the readings. Your commenting will help us focus our class meetings on the material that you all find most confusing or most interesting, and will give you experience in working through advanced material with your peers.
- **Problem sets:** There will be problem sets due approximately every other week, typically Fridays at 5:00pm Eastern time. Some of the problems may require deep thought, so you are strongly encouraged to begin them early and to brainstorm in groups of 2-3 students. (See Collaboration Policy below.)
- **Scribe notes:** students will be expected to type scribe notes for one or two class meetings during the semester. Depending on enrollment, this may be done solo or in pairs.
- **Final project:** You will do a final project on a topic of your choosing. Projects can be done individually or in pairs, with groups of three allowed for ambitious projects. Projects can involve implementing and experimenting with some of the algorithmic techniques in this area, giving an original presentation of material from the research literature that we didn't cover in class, and/or trying to obtain some new theoretical results. The project should provide good opportunities to connect the course material to your other interests and get some exposure to the frontier of research in spectral graph theory. The project will involve submitting topic ideas for feedback (due with problem set 2, 10/9, and revised as part of problem set 3, 10/23), a detailed project proposal (due 11/6, along with meeting with the course staff), a written paper (draft due in reading period, final version in exam period), and a project presentation (in exam period). We will post more details about the final project, including some directions to look for topics, early in the course.
- **Asynchronous Q&A and discussion:** We will use [Piazza](#) for Q&A, announcements, and discussions that are not attached to specific readings.
- **Equipment:** you should have a tablet that you can use for online brainstorming of mathematics with your classmates during breakout rooms in class and section and when working on problem sets and final projects. You can borrow an iPad and stylus from the Office of Undergraduate Education by calling (617) 495-7777.

Grading and Flexibility

The final grades for the course will be determined by roughly the following breakdown:

- 50% Problem Sets and Scribe Notes
- 25% Participation (in class meetings, section, office hours, Perusall, and/or Piazza)
- 25% Final Project

We recognize that the pandemic and remote learning may at times interfere with your ability to engage fully in the course. Thus, each of you will have 12 late days for the semester, of which you can use up to 3 days on any problem set, scribe note, or final project deadline. Do not use

them carelessly at the start of the term; save them for unexpected circumstances when you might really need them. Any extensions beyond the 12 late days requires a note from your resident dean (for undergraduates) or faculty advisor (for graduate students).

We will make recordings of all class meetings and sections available in case you are unable to attend or wish to rewatch them. If you must miss several meetings, please let us know so that you can fulfil the participation expectations in other ways.

Collaboration Policy

Students are encouraged to discuss the course material and the homework problems with each other in small groups (2-3 people). Discussion of homework problems may include brainstorming and talking through possible solutions, but should not include one person telling

the others how to solve the problem. In addition, each person must write up their solutions independently, and these write-ups should not be checked against each other or passed around. While working on your problem sets, you should not refer to existing solutions, whether from other students, past offerings of this course, materials available on the internet, or elsewhere. All sources of ideas, including the names of any collaborators, must be listed on your submitted homework.
